ACCREDITATION AND RELIGIOUS EXEMPT STATUS DISCLOSURE

Living Stones Christian University is a private religious institution operating in the State of Florida pursuant to the religious exemption provisions applicable to institutions offering programs exclusively religious in nature under Section 1005.06(1)(f), Florida Statutes.

The University is not accredited by an accrediting agency recognized by the United States Department of Education (USDE) or the Council for Higher Education Accreditation (CHEA).

The programs offered by Living Stones Christian University are designed exclusively for religious, theological, ministerial, and ecclesiastical purposes and are intended to prepare students for Christian service, ministry leadership, biblical studies, discipleship, theological education, and related religious vocations.

Because the institution operates under a religious exemption:

- The University does not participate in Title IV federal financial aid programs, including Pell Grants or federal student loans.
- Credits and degrees earned at the institution may not be recognized by employers, licensing boards, governmental agencies, or other colleges and universities.
- Transferability of credits and acceptance of degrees are always determined solely by the receiving institution, employer, or licensing authority.
- Programs are not designed to meet state professional licensure requirements in fields such as counseling, education, psychology, social work, or other state-regulated professions.
- The institution does not guarantee employment, ministry placement, professional certification, ordination, or salary outcomes.

- All degree programs are delivered primarily through fully online education utilizing asynchronous instructional delivery with virtual academic interaction where applicable.
- The University's programs are intended for individuals seeking biblical, theological, ministerial, leadership, and Christian service preparation consistent with the institution's religious mission and Statement of Faith.

Students are strongly encouraged to carefully evaluate their educational, vocational, ministerial, and professional goals before enrollment and to determine whether the University's religious educational model is appropriate for their intended purposes.
